- VI. **Diamond Melee Sorting Service** is available for up to 500 stones (< 3mm each) separated into natural, laboratory-grown and imitation and sealed in transparent bags, priced at **BHD 0.055 per stone.**
- VII. **Diamond Grading Service** available after stone identification and subject to terms and conditions.
- VIII. **Re-submission Service** is available where clients require a new report due to a change in the configuration of previously tested items. All resubmitted items must be reconciled with the original submission. A re-submission is priced at **50% of the applicable fee.**
